

Project of the Month

Evidences of Truth: Francisco Rodrigues SJ (c. 1515-1573) and Normative Knowledge Production in Early Modern Portuguese Asia -

A book project

This project aims to explore the life and times of an often-overlooked figure in the history of Jesuit missions in Asia: Francisco Rodrigues SJ (c. 1515–1573). A pivotal figure in the practical application of moral theology and canon law within missionary contexts, his writings influenced generations of confessors in areas under the patronage of the Iberian crowns.


This collective volume will illuminate Rodrigues' political engagements, the internal conflicts within the Society of Jesus during its initial decades in Portuguese India, the manifold applications of canon law and theology in the pragmatic normative literature produced in Jesuit colleges, and the contradictions and continuities in the production of normative literature in Asia compared to the Americas.

Touching on issues such as matrimony, baptisms, slavery, trade, taxation, and contracts, the chapters offer a multitude of perspectives. The final manuscript is expected to be submitted by mid-2025 to the publishers of the Max Planck Studies in Global Legal History of the Iberian Worlds series.

New in our library

Petrus Cornejo: *Theologia sholastica [sic] et moralis, quae diversas materias secundum tres partes D. Thomae Aquinatis, et ad mentem ejusdem Doctoris Angelici elaboratas continet. [...]* 2 Bde, Bambergae 1671-1672.

Die Institutsbibliothek hat eine Ausgabe (Bamberg 1671-1672) der theologischen Vorlesungen erworben, die der Karmelit Pedro Cornejo Pedrosa (gest. 1618) während seiner Lehrtätigkeit in Salamanca über die Summa theologiae des Thomas von Aquin hielt. Im ersten Band geht es um die Prima und die Prima Secundae der Summe, im zweiten um die Tertia. Dagegen fehlen Ausführungen zur Secunda Secundae, die man schon in

der ersten und zugleich einzigen früheren Ausgabe (Valladolid 1628-1629) vergebens sucht. Cornejo, der neben seiner akademischen Tätigkeit u. a. Philipp III. beriet, zeigt sich in seinen Abhandlungen durchaus an praktischen Fragen interessiert und beantwortet sie auch auf der Grundlage der zeitgenössischen thomistischen Literatur. Wenngleich er zu seinen Lebzeiten als einer den führenden Interpreten des Aquinaten galt, sind Werk und Wirkung dieses Theologen bis heute noch weitgehend unerforscht.
